### **Preamble:**

As per GR dated 18-4-2015 referred to at Sr. No. (6) above, the condition No. 7 of the said GR, the last date for generating crop insurance Proposal Form on i-khedut portal is 31st July 2015 (column 3 of table-1) while time period for submitting proposal form to the concern bank should not be later than week of the aforesaid prescribed time limit (Sub para-A of Step-1) under NAIS-Kharif-2015 for Loanee and Non loanee farmers and last date of submitting consolidated statement to AIC for insurance coverage (column 4 of table-1). There have been several requests of farmers and representations from the various stakeholders to the State Government regarding extension of the date for submitting proposal form to concerned bank.

The matter was discussed extensively in SLCCCI dated 8/9/2015 and decided to extend the date of submitting proposal form to concern bank of those farmers who had apply online on and before 31/7/2015. Accordingly, with referred to at Sr. No. (8) above, it has been considered to extend the aforesaid time limit for submitting proposals for those farmers who had apply online on and before 31/7/2015 in the GR dated 18-4-2015 as follows:

### **Resolution:**

In partial modification in Condition at 7 of GR dated 18-4-2015, the Government has decided to extend the cut-off date for submitting crop insurance Proposal Form on i-khedut portal up to 15th September 2015 for participation of those farmers who had apply online on and before 31/7/2015 under NAIS during Kharif 2015 and the last date of submission of proposal form to the concerned bank by the farmers shall be 15th September 2015 and last date of submitting consolidated statement to AIC by bank for insurance coverage shall be 30<sup>th</sup> September 2015.
