**Preamble:**

In the GR dated 16/04/2016 referred to at Sr. No. (2) above, at the condition No. 5(A), Farmers have to furnish their online proposal form to the concerned banks within stipulated time limit. It is represented by the banks in the meeting of dated 01.07.16 regarding difficulties faced by them in making online applications on behalf of the loanee farmers. In view of matter, it has been discussed in the meeting dated.1-7-2016 and considered as under:

**Resolution:**

In partial modification in Condition No.5(A) of GR dated 16/04/2016 mentioned at (2) in preamble, Government has decided that all banks have to deduct the premium of loanee farmers accordance with the provisions of PMFBY guidelines on and before 15-7-2016 and to submit the certified list of loanee farmers along with name, premium, notified crops, crop area and sum insured to the implementing agency/agencies very next day i.e., 16-7-2016. The bank shall prepare computerized record on i-khedut Portal of the applications made upto 15-7-2016. This should be completed before 31-7-2016 for the farmers who are included in the certified list given by the bankers on 16-7-2016. The relevant documents regarding crops and their insured area should also be verified by the respective banks.
