Preamble:

Government has issued G.R. No. PFB-102017-836-K.7 dated 1/4/2017 to implement Pradhan Mantri Fasal Bima Yojana - PMFBY for Kharif-2017 and Rabi-Summer, 2017-18. In note Table-A in column (6) for Kharif season, it is stated that "Within 15 days for Loanee farmers (i.e. 31/07/17) and 7 days for non loanee farmers (i.e. 21/07/17) after cut off dates for submission of premium by concerned bank to concerned Insurance company for insurance purpose" for all Kharif Crops except Castor and Banana Crops by concerned bank to Concerned Implementing Agency.


But due to late submission of bank account details by New India Assurance Company Ltd. and SBI General Insurance Company Ltd., the cut-off date for submission of Premium by concerned bank to Implementing Agencies (i.e New India Assurance Company Ltd. and SBI General Insurance Company Ltd.) has been decided to be extended as under.

Corrigendum:

The last date for Submission of Premium by concerned banks to concerned Implementing Agencies of Loanee and Non-loanee farmers for all Kharif Crops except Castor and Banana was decided as 31/7/2017 & 21/07/2017 respectively, **which is**

extended here by up to 05/08/2017 for the Clusters-1 2 5 & 6 only and Banks should also certify that they have debited the premium of farmers on or before 20/07/2017.
